Thank you for your Freedom of Information request of 25 June 2025. We are responding to you under the Freedom of Information (Scotland) Act 2002 [FOISA].

## FOI REQUEST (25 June 2025)

Under the Freedom of Information (Scotland) Act 2002, I am writing to request the following information regarding public investment in alcohol-related industries, including but not limited to the whisky and spirits sector:

### 1. Public Grants and Financial Support

Please provide a list of all companies operating in the alcohol industry that have received public funding, support, or investment from your agency since 1 January 2010, including:

- b. Amount awarded (grant, loan, or equity investment)
- c. Type of support (grant/loan/equity/in-kind support)

- e. Stated purpose of funding
- f. Current status of funding (e.g. repaid, written off, ongoing)

If applicable, please include both direct and indirect beneficiaries, such as alcohol supply chain partners (e.g. bottling, marketing, distillation equipment, etc.).

### 2. Due Diligence and Ethical Oversight

Please provide any internal documentation, board papers, or ministerial correspondence where consideration was given to:

- a. Potential conflict between support for alcohol producers and public health goals
- b. Alignment (or contradiction) with Scottish Government health policies, including alcohol harm reduction, minimum unit pricing, and prevention strategies
- c. Any ethical review frameworks used to assess applications from alcohol-related companies
