

## SOUTH OF SCOTLAND ENTERPRISE PUBLIC SERVICES REFORM (SCOTLAND) ACT 2010: STATEMENT 2024/25

Under the Public Services Reform (Scotland) Act 2010, we have, along with other public bodies in Scotland, a duty to publish annual public statements relating to our expenditure in the following areas:

- Public relations
- Overseas travel
- Hospitality and entertainment
- External consultancy

In addition, the Act requires public bodies to publish details on:

- Payments with a value in excess of £25,000 (APPENDIX 1)
- Employees/members who receive remuneration in excess of £150,000.
