- 1. Our SIC 2007 code is SIC 84110 (General public administration activities)
- 2. SOSE have 145 employees (as of 21 April 2025)
- 3. Public SOSE is a Non-Departmental Public Body (NDPB)
- 4. We cover the South of Scotland Dumfries and Galloway and Scottish Borders Regions
- 5. We work with the Public and Commercial Services Union (PCS)
- 6. Our last pay settlement came into effect on 1 April 2024
- 7. The next pay settlement is currently under negotiation
- 8. The £1,500 consolidated pay increase equates to 6.45% increase, this is based on lowest paid employee.
- 9. The 2024/25 settlement was a tiered uplift and not standard across all grades and front loaded for lower paid staff. Grade A £1,500 consolidated uplift, Grade C to G 3%, Grade H 2.5%.
- 10. Our lowest paid employees are Modern Apprentices with an hourly spot rate of £14.88 per hour. Our Support Staff hourly rate range is £16.19 to £17.87.
- 11. SOSE is a living wage employer
